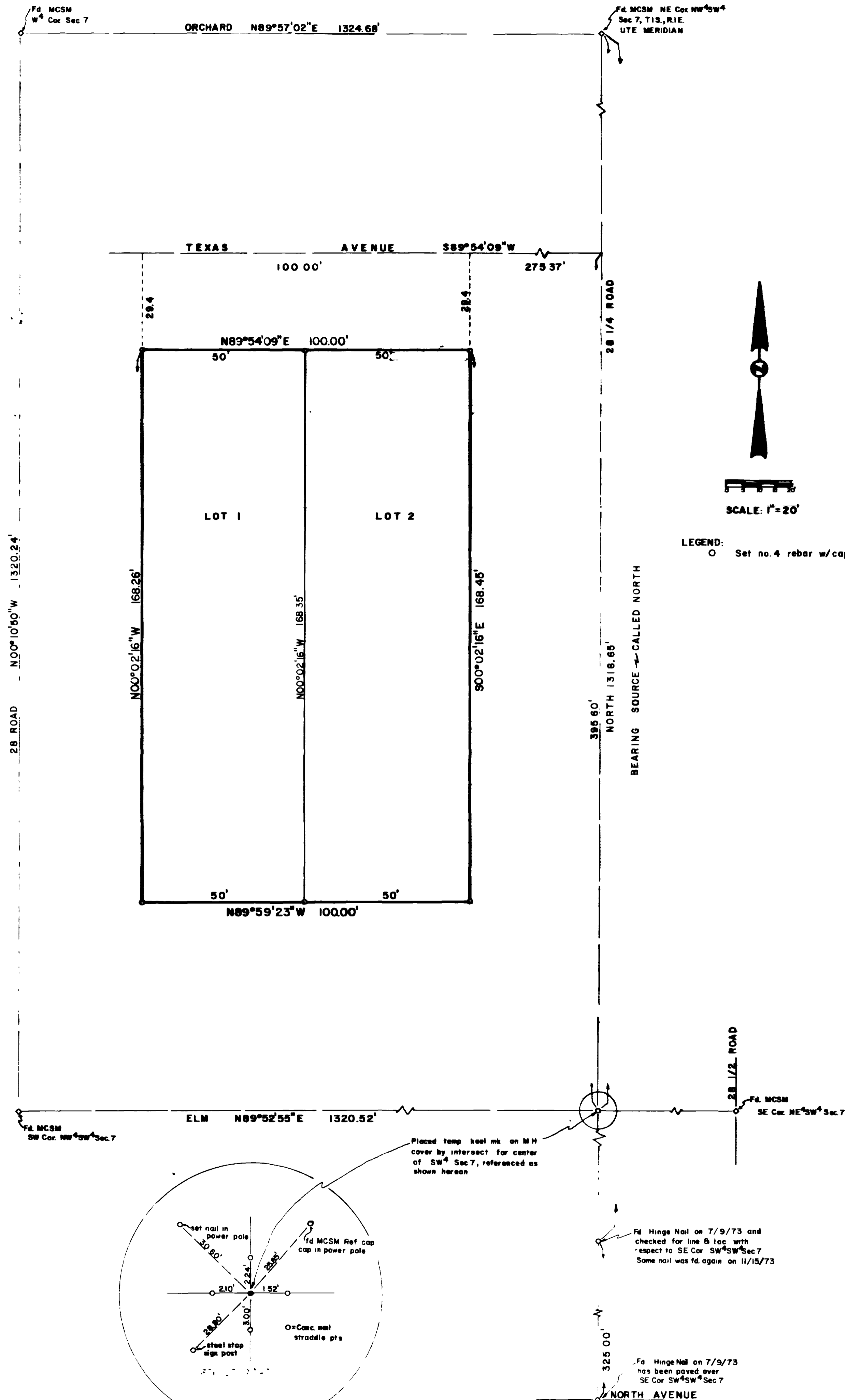


BROKEN ARROW SUBDIVISION



DEDICATION

KNOW ALL MEN BY THESE PRESENTS, That the undersigned, Earl Warner and Wayne D. Callahan are the owners of that real property situated in the City of Grand Junction, County of Mesa, State of Colorado, and lying in the City of Grand Junction, Mesa County, Colorado, being more particularly described as follows: The N^{1/2} of the East 100.00 ft. of the following tract of land: the W^{1/2} E^{1/2} S^{3/4} SE^{1/4} NW^{1/4} SW^{1/4} and the E^{1/2} W^{1/2} S^{1/2} SE^{1/4} NW^{1/4} SW^{1/4} of Sec. 7, T15, R1E, of the Ute Meridian; EXCEPT the North 29.4 ft. thereof reserved for Road purposes, as shown by the accompanying plat thereof.

That the said owners have caused the said real property to be laid out and surveyed as Broken Arrow Subdivision, a subdivision of a part of the City of Grand Junction:

That said owners do hereby dedicate and set apart all of the streets and roads as shown on the accompanying plat to the use of the public forever and hereby dedicate those portions of said real property which are labeled as utility easements on the accompanying plat as easements for the installation and maintenance of such utilities as telephone and electric lines, poles and cables, storm and sanitary sewer mains, water mains, gas pipe lines and those portions of said real property which are labeled as irrigation easements on the accompanying plat as easements for the installation and maintenance of irrigation ditches, flumes and conduits;

That all expenses for installation of utilities or ditches referred to above, for grading or landscaping, and for street grading or improvements shall be financed by the seller or purchaser... of the City of Grand Junction.
