> Beginning at a point which is North 381.16 feet from the Southeast Corner of Section 3, Township I South, Range I West of the Ute Meridian, thence North 395.0 feet, thence West 2500 feet, thence North 1900 feet, thence East 250.0 feet, thence North 1808 feet, thence West 6599 feet, thence S0°05'30"E 484.48 feet, thence N 87°57'E 116 85 feet, thence S 65°53'E 78 2 feet, thence S 34°10'E 127 82 feet, thence N 87°41'E 400.33 feet to the POB Except the North 10 feet of the West 265 feet thereof
