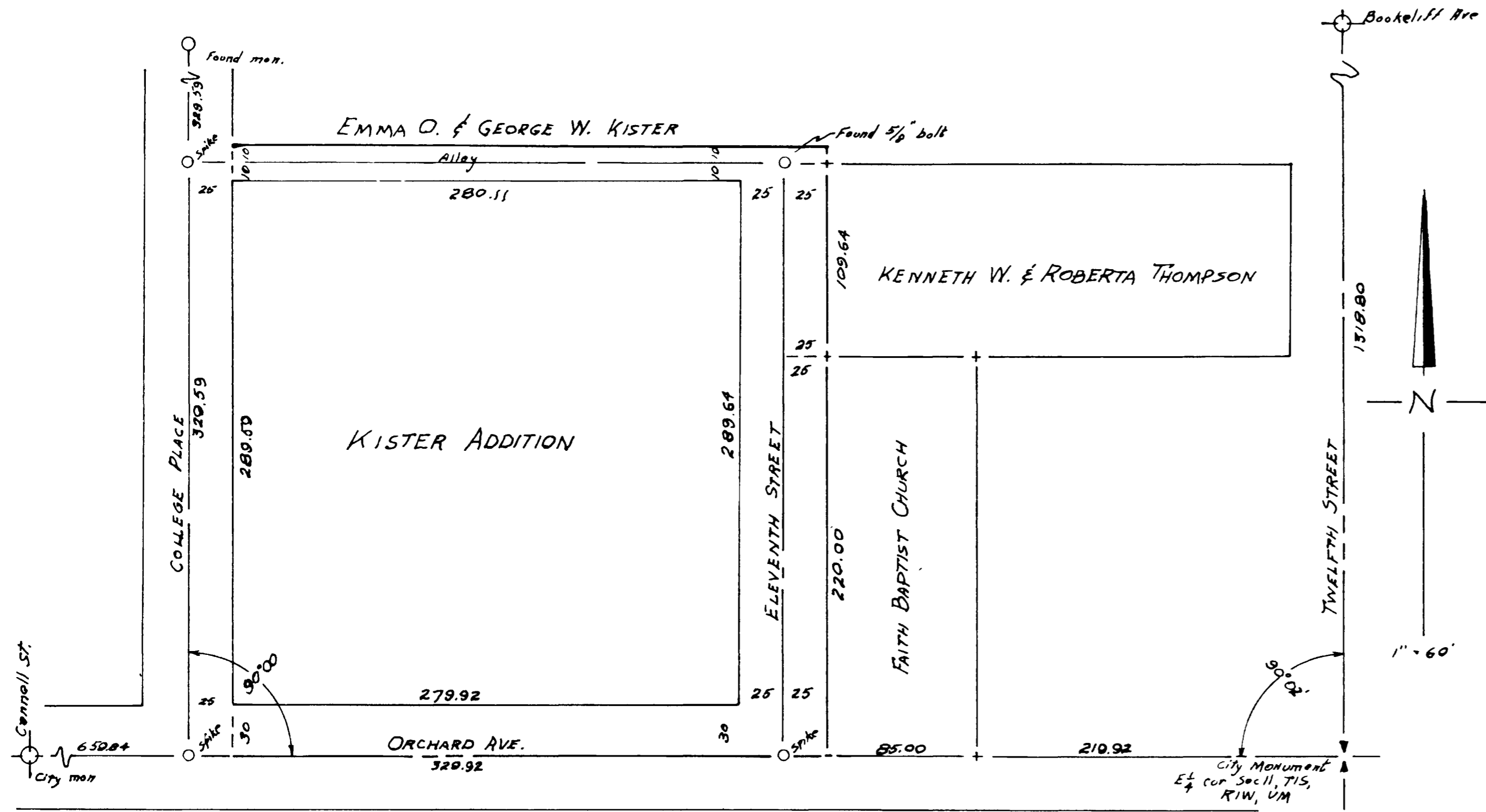


DEDICATION
