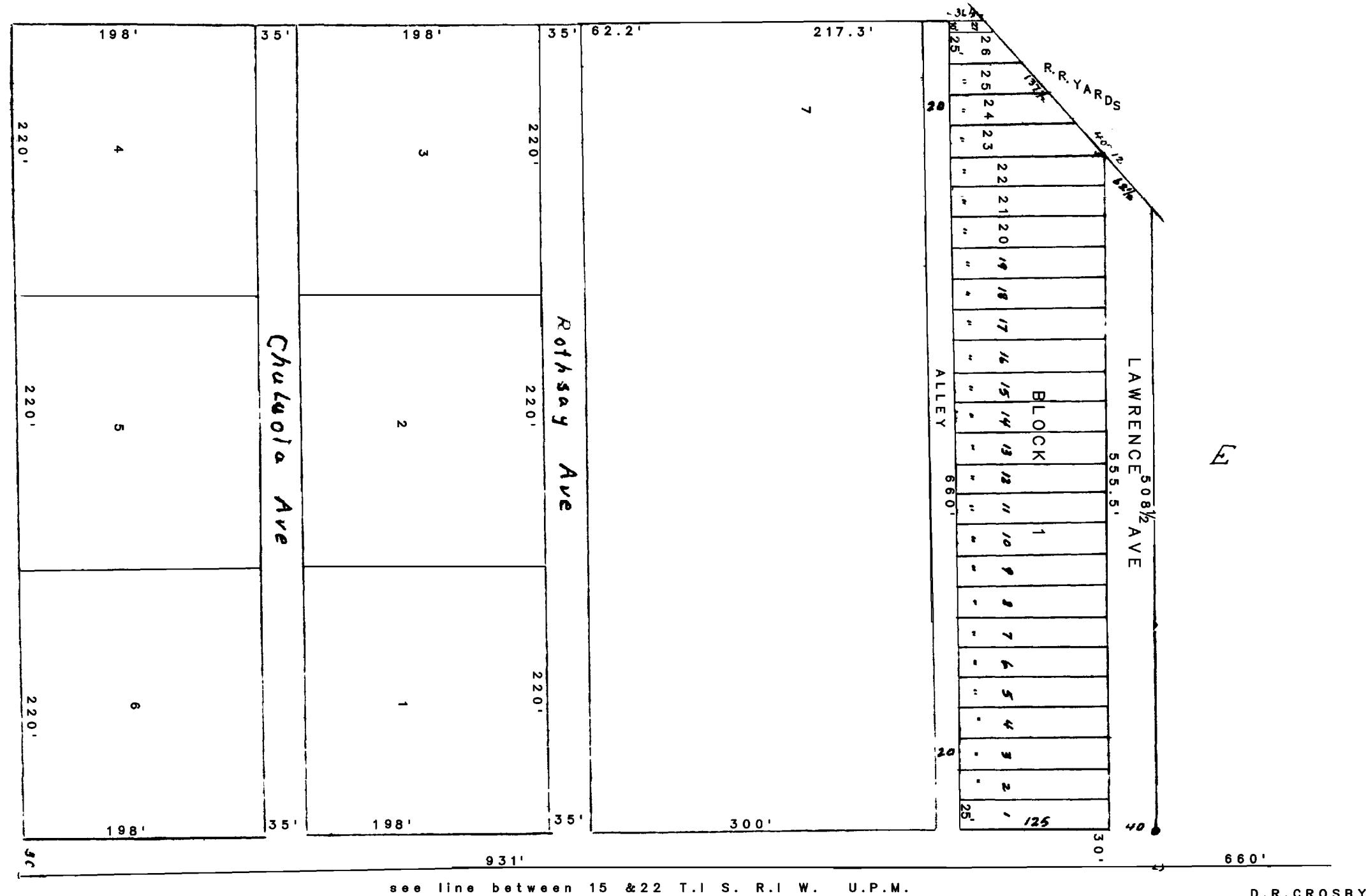


THOMAS B CRAWFORD
