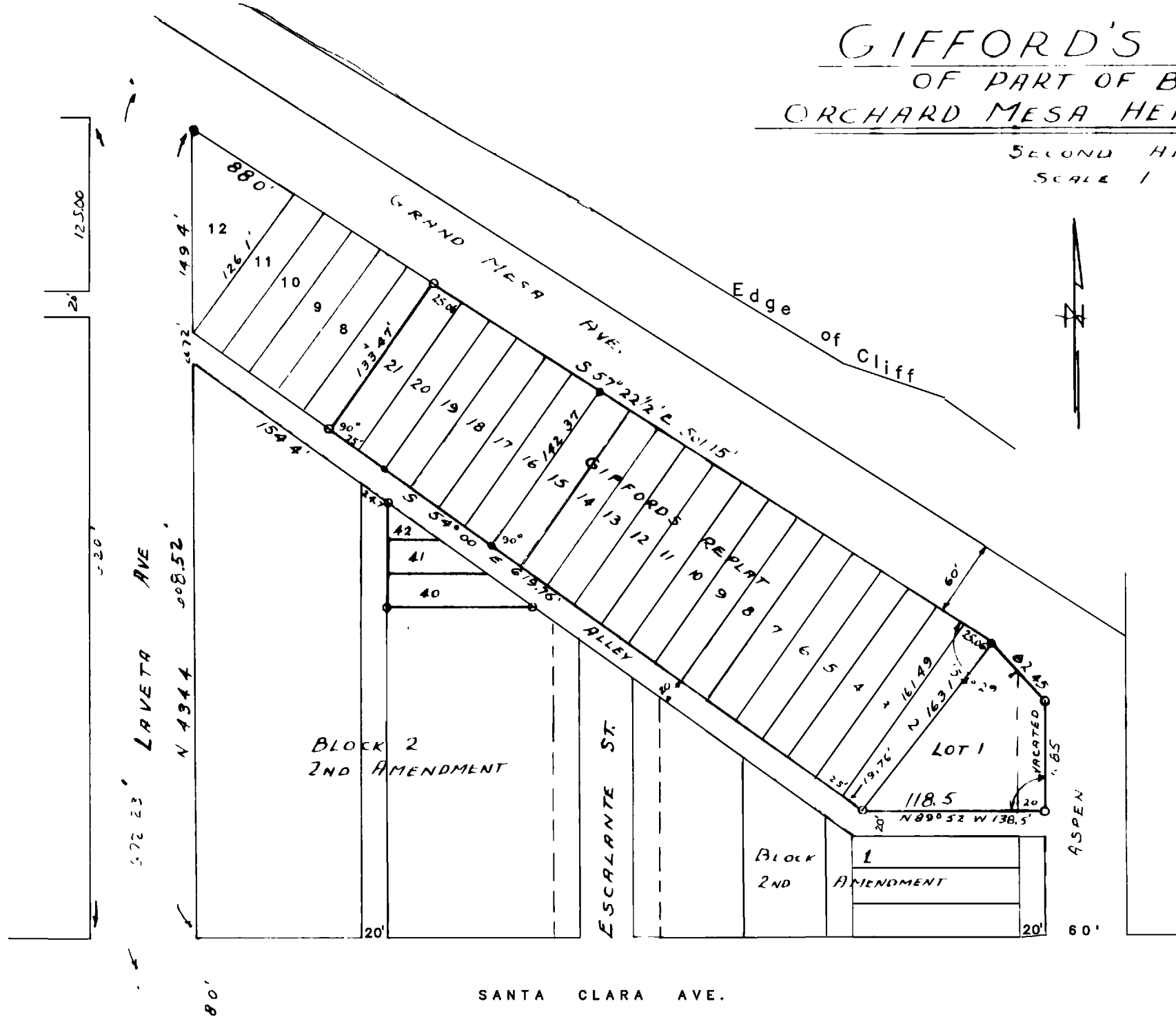
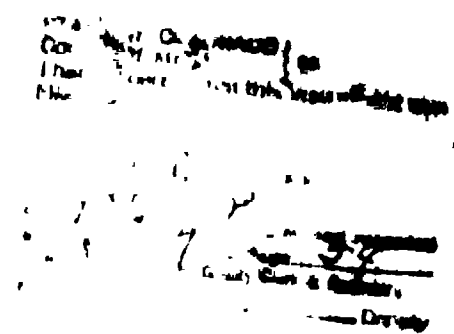


**GIFFORD'S REPLAT**
