# AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF GRAND JUNCTION, COLORADO TERRA DEL VISTA ANNEXATION - APPROXIMATELY 9.0 ACRES LOCATED EAST OF 7TH STREET, SOUTH OF I-70

WHEREAS, on the 16th day of December, 1992, the City Council of the City of Grand Junction considered a petition for the annexation of the following described territory to the City of Grand Junction; and

WHEREAS, a hearing on the petition was duly held after proper notice on the 20th day of January, 1993; and

WHEREAS, the City Council determined that said territory was eligible for annexation and that no election was necessary to determine whether such territory should be annexed;

A tract of land located in the SW1/4 of the NE1/4 and the NW1/4 of the SE1/4 of Section 35, Township 1 North, Range 1 West of the Ute Meridian, Mesa County, Colorado, said tract being more particularly described as follows:

Beginning at the Center 1/4 Corner of said Section 35; thence East along the centerline of G-1/2 Road a distance of 30.0 feet; thence South a distance of 25.0 feet to the South Right-of-Way of G-1/2 Road; thence East along the South Right-of-Way of G-1/2 Road a distance of 627.9 feet; thence North a distance of 50.0 feet to the Southeast corner of Terra Del Vista Subdivison as recorded in Plat Book 8 at Page 76 in the office of the Mesa County Clerk and Recorder; thence North along the East



- 1. S87°48'30"W 127.38 feet;
- 2. along the arc of a curve to the left whose radius is 1527.1 feet and whose long chord bears S83'13'00"W 214.38 feet;
- 3. S83'11'30"W 81.5 feet;
- 4. S71°36'W 171.9 feet;
- 5. S11°30'30"W 209.0 feet;
- 6. N89°40'W 32.0 feet to the West line of the SW1/4 NE1/4 of said Section 35;

thence South along the West line of the SW1/4 NE1/4 of said Section 35 a distance of 397.6 feet to the Point of Beginning.
