



# DEDICATION

KNOW ALL MEN BY THESE PRESENTS

That the undersigned, George Towns, Lauralee Towns, Carl E Aller and Edna M Aller are the owners of that real property situated in the County of Mesa, State of Colorado as shown by the accompanying plat thereof, and described by metes and bounds as follows

Beginning at a point whence the SW Corner of the SWI/4 NEI/4 of Section 25, Township I South, Range I West, of the Ute Meridian bears West 330.0 feet, thence North 13200 feet, thence East 330.0 feet; thence South 13200 feet, thence West 330.0 feet to the point of beginning.

That the said George Towns, Lauralee Towns, Carl E Aller and Edna M. Aller have caused the said real property to be laid out and surveyed as TOWNS SUBDIVISION, a subdivision of a part of the County of Mesa,

That said George Towns, Lauralee Towns, Carl E Aller, and Edna M. Aller hereby dedicate and set apart all of the streets evenues and roads as shown on the accompanying plat to the use of the public forever and hereby dedicate those portions of said real property which are labeled as utility easements on the accompanying plat as easements for the installation and maintenance of telephone and electric lines, poles and underground cables, storm and sanitary sewer mains; water mains, gas pipe lines, and those portions of said real property which are labeled as irrigation easements for the installation and maintenance of irrigation ditches, flumes and conduits;

That all expenses involving necessary improvements for a water system, sanitary sewer system, gas service, electrical service, grading and landscaping, storm sewer system, curbs and gutters, street pavement and sidewalks shall be financed by the purchaser or seller\_\_\_ not the County of Mesa.
