## DEDICATION

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned William H. Buttolph and Averial A. Buttolph are the owners of that real property situated in the City of Grand Junction, State of Colorado and being in a part of the N.W.1/4 of the S.E.1/4 of Section 10, T.1S, R.1W of the Ute Meridian, said real property being more particularly described as follows:

Commencing at the Southeast Corner of the Northwest Quarter (NW1/4) of the Southeast Quarter of said Section 10 and considering the South line of the Northwest Quarter of the Southeast Quarter to bear North 89°47'00" West with a 11 bearings contained herein relative thereto; Thence North 89°47'00" West 40.00 feet to the True Point of Beginning; Thence containing North 89°47'00" West, 224.00 feet along the South line of the Northwest Quarter (NW1/4) of the Southeast Quarter of said Section 10; Thence North 00°00'00" East 330.00 feet; Thence South 89 47'00" East 244.00 feet; Thence South 08°45'04" West 131.46 feet; Thence South 00°00'00" West 200.00 feet to the True Point of Beginning. Containing 1.726 Acres.

That said owners have caused the said real property to be laid out and surveyed as Monument View Subdivision, a subdivision of a part of the city of Grand Junction, County of Mesa, State of Colorado.

That said owners do hereby dedicate and set apart all of the streets, avenues and roads as shown on the accompany-ing plat to the use of the public forever and dedicate to the utility companies those portions of said real property, which are labeled as utility essements on the accompanying plat, as essements for the installation and maintenance of such utilities as telephone, electric lines, poles and cables, storm and sanitary sewer mains, gas pipelines, with further right of ingress and egress to and from the above described utility easements, and those portions of said real property which are labeled as irrigation easements for the installation and maintenance of irrigation ditches, flumes and conduits, and those portions of said real property which are labeled as drainage easements for the installation and maintenance of drainage ditches, flumes and conduits.




