KNOW ALL MEN BY THESE PRESENTS:

DEDICATION

That the City of Grand Junction, is the owner of the real property, situated in the Veteran Cemetery as recorded in book 12, page 80, Mesa County Clerk and Recorder, Mesa County, Colorado and lying in the SW 1/4 of the NW 1/4 of Section 26, Township I South, Range I West of the Ute Meridian. The Veterans Cemetery Replat, as shown on this accompanying Plat, being a Portion of said Veterans Cemetery and more clearly described as follows.

Beginning at a point 770.22 feet West of the NE Corner of SW 1/4 of the NW 1/4 of said Section 26 Thence South 41.80 feet along the East boundary of the Veterans Cemetery to a point , Thence West 10.50 feet, Thence South 0.20 feet, Thence West 50.50 feet, Thence North 0.20 feet, Thence West 11.50 feet, Thence North 0.20 feet, Thence West 21.50 feet, Thence North 41.60 feet to a point on the North Line of said Veterans Cemetery, Thence East 94.00 feet to the Point of Beginning.

That the City of Grand Junction has caused the replat of the above described Property as being a paths and parks lying in the replat of the Veterans Cemetery as so described above has been vacated by ordinance no. 1898 Portion of the Veterans Cemetery and that Portion so dedicated to the Public forever as streets, walkways,

And that the City of Grand Junction does hereby dedicate all of the streets, walkways, paths and parks as shown on the accompanying plat to the use of the Public forever


