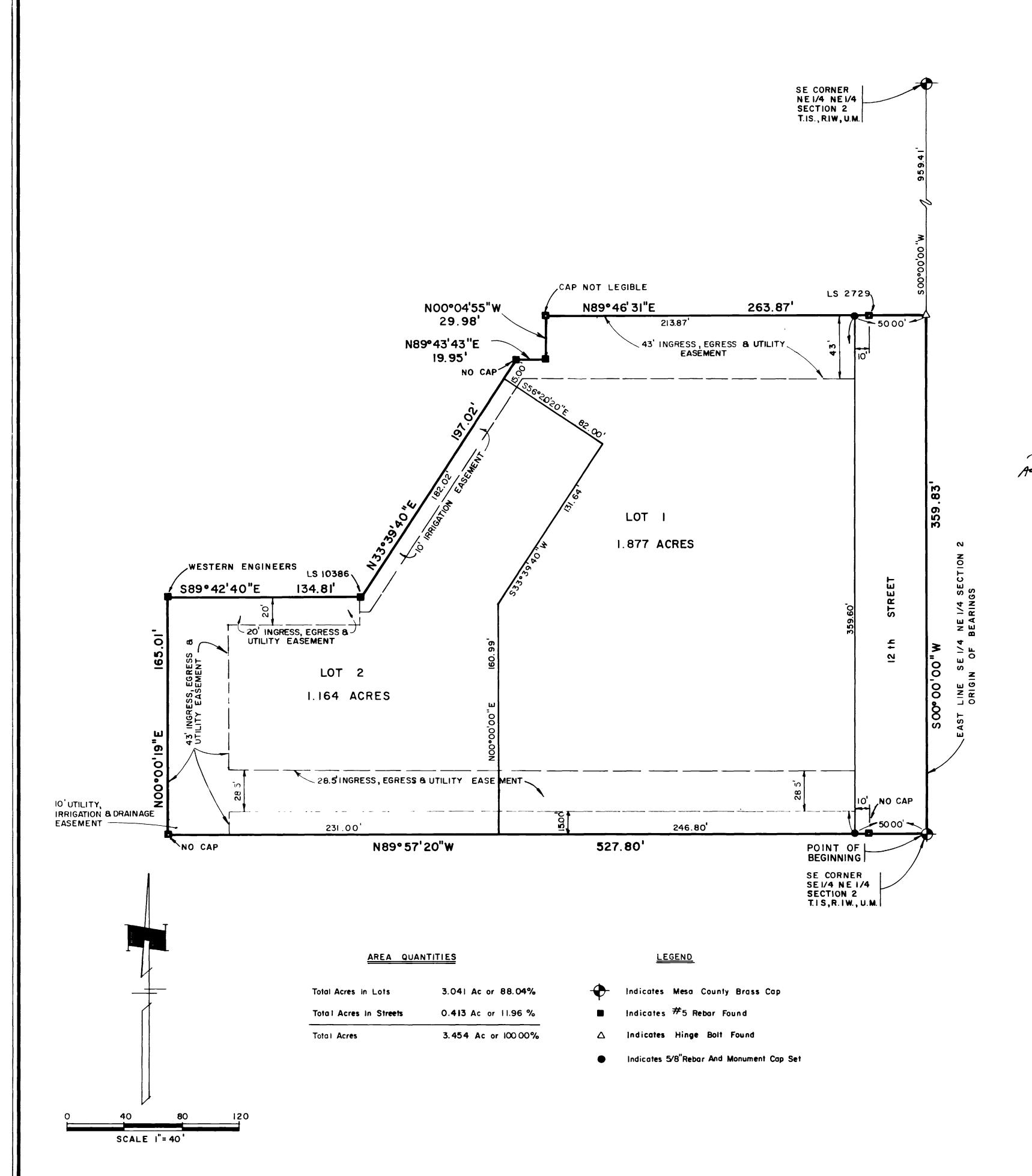

DEDICATION

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned Destination Properties, Inc., a California Corporation, is the owner of a part of the SE 1/4 NE 1/4 of Section 2, Township 1 South, Range 1 West of the Ute Meridian, City of Grand Junction, County of Mesa, State of Colorado, as shown on the accompanying plat thereof, said tract being more particularly described as follows:

Beginning at the SE Corner of the SE 1/4 NE 1/4 of said Section 2; Thence N 89° 57' 20" W 527.80 feet; Thence N 00° 00' 19" E 165.01 feet; Thence S 89° 42' 40" E 134.81 feet; Thence N 33° 39' 40" E 197.02 feet; Thence N 89° 43' 43" E 19.95 feet; Thence N 00° 04' 55" W 29.98 feet; Thence N 89° 46' 31" E 263.87 feet to a point on the east line of the SE 1/4 NE 1/4 of said Section 2; Thence S 00° 00' 00" W along said east line of the SE 1/4 NE 1/4 of Section 2 a distance of 359.83 feet to the point of beginning, containing 3.454 acres.

That said owner has caused the said real property to be laid out and surveyed as Northwood, a subdivision of a part of the City of Grand Junction, County of Mesa, State of Colorado.

That said owner does hereby dedicate and set apart 50 feet for 12th Street as shown on the accompanying plat to the use of the public forever, and hereby dedicates to the Public Utilities those portions of said real property which are labeled as utility easements on the accompanying plat as perpetual easements for the installation and maintenance of utilities, irrigation and drainage facilities, including but not limited to electric lines, gas lines, telephone lines; together with the right to trim interfering trees and brush; with perpetual right of ingress and egress for installation and maintenance of such lines. Such easements and rights shall be utilized in a reasonable and prudent manner. The areas shown as ingress, egress and utility easements are dedicated to the owners of the property within sold Northwood for perpetual ingress and egress for themselves public and private agenains including but not limited to postal services, trush, fire, police and emergency vehicles.
