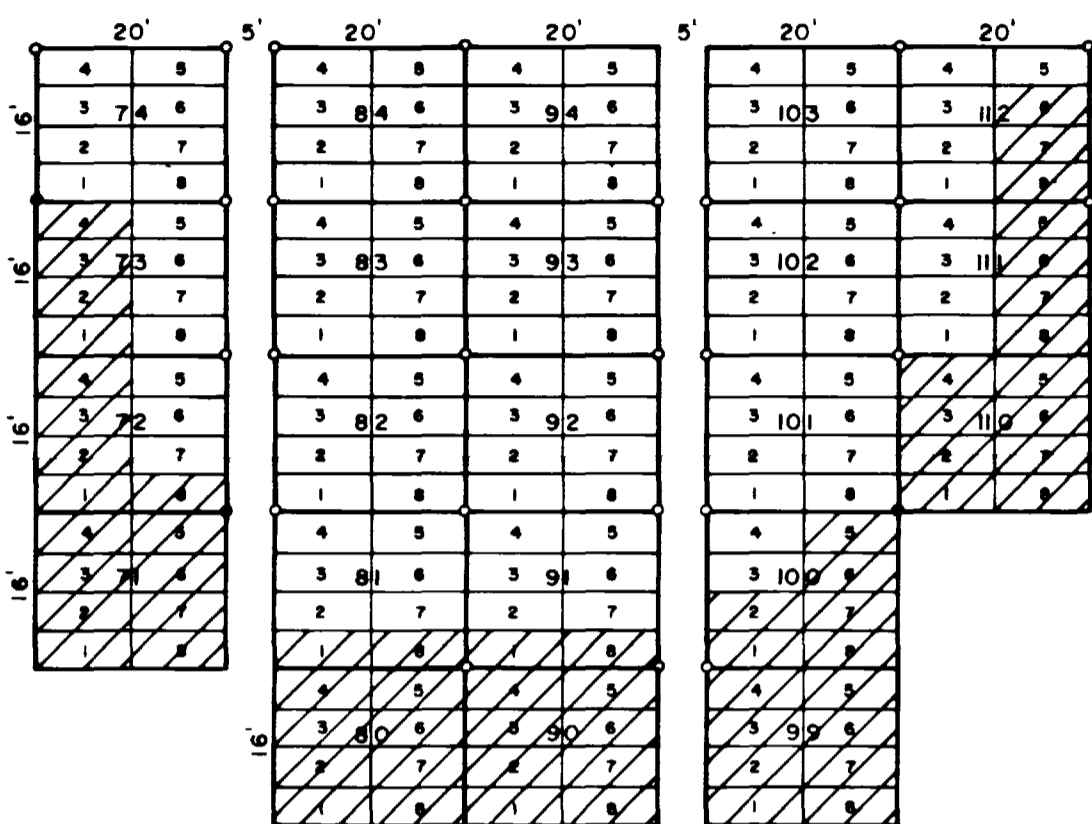


**A REPLAT OF A PORTION

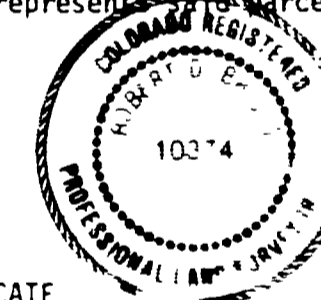

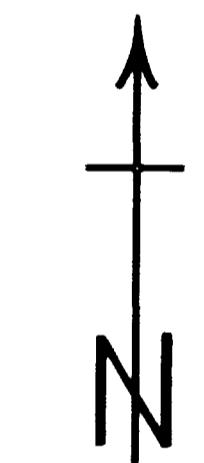
