DEDICATION

KNOW ALL MEN BY THESE PRESENTS.

That Gary Springfield and Richard Scariano

lying in the SW 1/4 Section 30, Township I South, Range I East, Ute Meridian, as shown by the accompanying plat thereof; said tract being more specifically described by metes and bounds as follows

Beginning at a point from whence the NE Corner SW1/4 of Section 30, Township | South Range | East of the Ute Meridian bears N89°56'22" E 199.0 feet and N00°04'E 1315.21 feet, said point lying on the South line of the NE 1/4 SW1/4 of Section 30, thence along said South line S89°56'22"W 240.0 feet, thence N0°04'E 1400 feet, thence N89°54'W 200 feet, thence along the arc of a 500 foot radius curve to the right 261.8 feet (the chord of which bears NO°06'E 500 feet), thence NO°04'E 483.0 feet, thence along the arc of a 50.0 foot radius curve to the right 261.8 feet (the chord of arc of a which bears NO°06'E 50.0 feet) thence NO°04'E 190.43 feet, thence S89°54'E 105 0 feet, thence along the arc of a 50.0 foot radius curve to the right 2618 feet (the chord of which bears S89°54'E 50.0 feet), thence S89°54'E 105.0 feet, thence S0°04'W 912.77 feet to the point of beginning.

That said owners do hereby dedicate and set apart all of the streets, avenues, roads and walkways as shown on the accompanying plat to the use of the public forever and hereby dedicate to the Public Utilities those portions of said real property which are labeled as utility easements on the accompanying plat as easements for the installation and maintenance of such utilities as telephone, electric and cable television lines, poles and-cables; storm and sanitary sewer mains; water mains; gas pipe lines; with further right of ingress and egress to and from the above described utility easements; and those portions of said real property which are labeled as irrigation easements on the accompanying plat as easements for the installation and maintenance of irrigation ditches, flumes, and conduits; and those portions of said real property which are labeled as drainage easements. for installation and maintenance of drainage ditches, flumes, and conduits

That all expenses for installation of utilities or ditches referred to above, for grading or landscaping, and for street graveling or improvements shall be financed by the seller or purchaser ---- not the County of Mesa.
