Commencing at the Southeast Corner of the SE1/4 NW1/4 NW1/4 of said Section 26, and considering the East line of the said SE1/4 NW1/4 NW1/4 to bear due North with all bearings contained herein to be relative thereto; Thence North along the East line of the said SE1/4 NW1/4 NW1/4 a distance of 243.32 feet; Thence West a distance of 20.0 feet to the True Point of Beginning; Thence West a distance of 110.0 feet; Thence North a distance 200.0 feet; Thence east a distance of 110.0 feet; Thence South a distance of 200.0 feet to the True Point of Beginning.

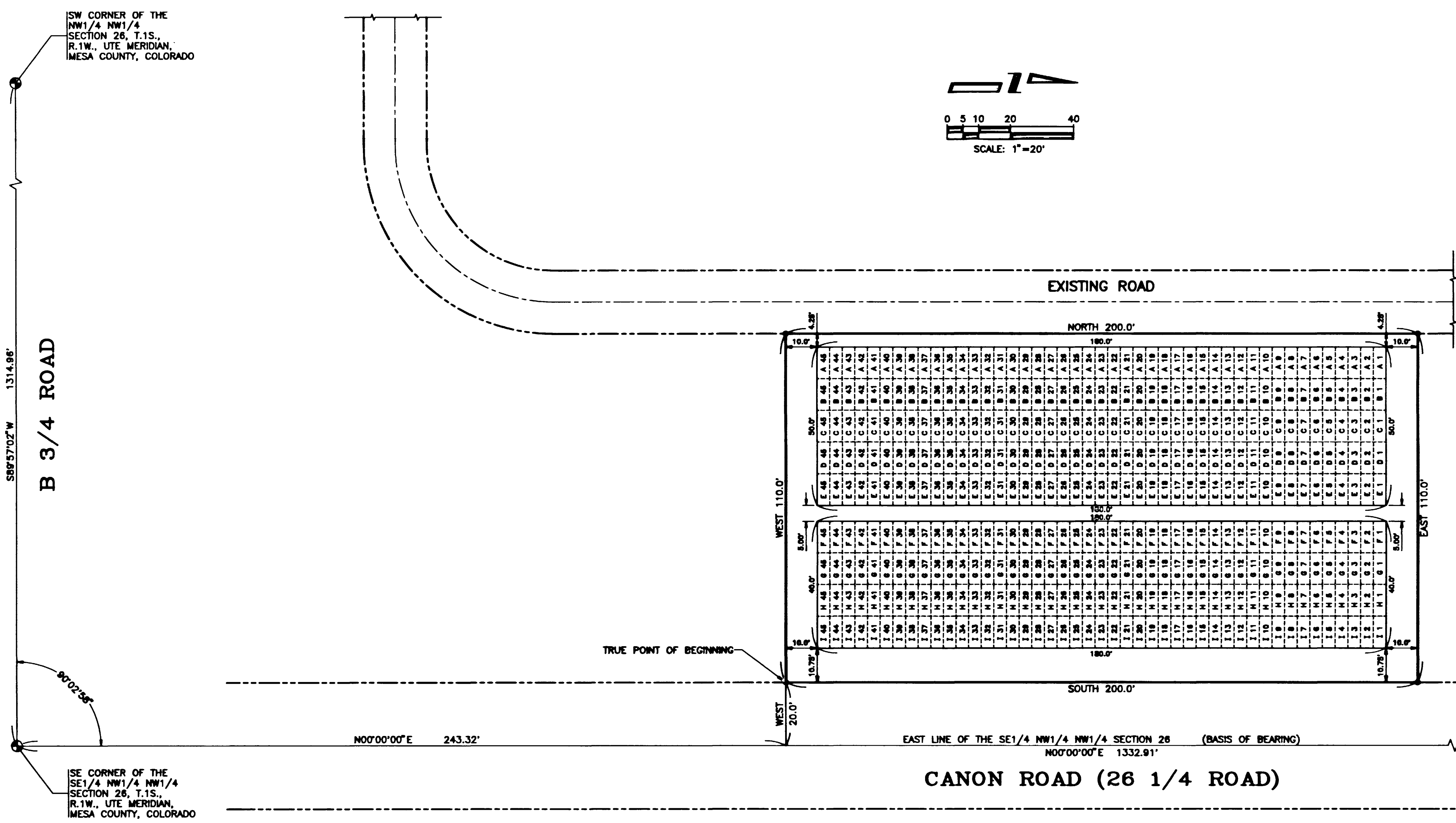
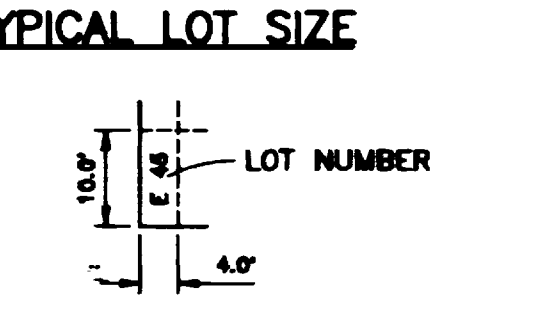
