

## KNOW ALL MEN BY THESE PRESENTS

That the undersigned, Robert H. Throm and Gary Albert are the owners of a parcel of land situated in the Northwest guarter of the Southwest guarter of the Northwest guarter of Section 19, Township I South, Range I East, of the Ute Meridian, Mesa County Colorado, said parcel of land being more particularly described as follows:

Beginning at a point which is located 168.80 feet South and 30.00 feet East of the Northwest corner of the Southwest quarter of the Northwest quarter of said Section 19; the West line of said Northwest quarter of Section 19 bearing North 00°00'00" East, with all bearings herein related thereto; thence South 89°26'49" East, 373.48 feet; thence South 00°04'24" East, 170.04 feet; thence Southwesterly 115.46 feet along the arc of a curve whose central angle is 90°37'20", whose radius is 73.00 feet and whose chord bears South 45°14'16" West, 103.80 feet; thence South 89°27'04" East, 63.25 feet; thence Southwesterly 213.47 feet along the arc of a curve whose central angle is 244°37'23", whose radius is 50.00 feet and whose chord bears South 32°51'37" West, 84.52 feet; thence Northwesterly 22.56 feet along the arc of a curve whose central angle is 64° 37'23", whose radius is 20.00 feet, and whose chord bears North 57°08'22" West, 21.38 feet; thence North 89°27'04" West, 299.42 feet; thence North 00°00'00" East, 303.86 feet to the point of beginning, containing 2.69 acres, more or less. That said owners have caused the said real property to be laid out and surveyed as BONNELL COMMERCIAL PARK FILING TWO, a planned development of a part of Mesa County, Colorado.
