KNOW ALL MEN BY THESE PRESENTS:

THAT THE UNDERSIGNED, BOBBY J. WHITE AND A. LOUISE WHITE ARE THE OWNERS OF THAT REAL PROPERTY SITUATED IN THE COUNTY OF MESA, STATE OF COLORADO, AND IS DESCRIBED IN BOOK 960 AT PAGE 533 OF THE MESA COUNTY CLERK AND RECORDERS OFFICE, AND BEING SITUATED IN TRACT 39 SECTION 35, TOWNSHIP 11 SOUTH, RANGE 101 WEST, SIXTH PRINGIPAL MERIDIAN, MESA COUNTY, COLORADO AS SHOWN ON THE ACCOMPANYING PLAT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS:

ALONG THE EAST LINE OF SAID TRACT 39 A DISTANCE OF 2,552.48 FEET TO THE SOUTHEAST CORNER OF SAID TRACT 39; THENCE N. 89°46'00" W. ALONG THE SOUTH LINE OF SAID TRACT 39 A DISTANCE OF 288.80 FEET; THENCE N. 04°09'00" E. 461.10 FEET; THENCE N. 20°43'00" W. 238.16 FEET TO A POINT ON THE EASTERLY RIGHT-OF-WAY OF QUAIL DRIVE AS RECORDED IN BOOK 919 AT PAGE 644 AND IN BOOK 974 AT PAGE 694 IN THE OFFICE OF THE CLERK AND RECORDER, MESA COUNTY, COLORADO; THENCE ALONG SAID EASTERLY RIGHT-OF-WAY BY THE FOLLOWING SIX (6) COURSES AND DISTANCES:
