
## LINCOLN LANE SUBDIVISION

KNOW ALL MEN BY THESE PRESENT

That the undersigned Robert Lavern Freeman, Barbara Jeanne Freeman, Melvin J. Reese, Syble Reese, Harley D. Brammell, Theda N. Brammell, Howard E Davis, Dorothy M. Davis and Arnold E. Frey are the owners of that real property situated in the County of Mesa, State of Colorado, and lying in the NE¼ NE¼ Section 30, Township I South, Range I East of the Ute Meridian, as shown by the accompanying plat thereof, said tract being more specifically described by metes and bounds as follows

> Beginning at a point which is West 415.0 feet from the East 4 Corner of Section 30, Township I South, Range I East of the Ute Meridian, thence South 180.0 feet, thence East 75.0 feet, thence South 480.0 feet, thence West .95.0 feet, thence North 200.0 feet, thence West 150.0 feet, thence North 60.0 feet, thence East 150.0 feet, thence North 400.0 feet, thence East 20.0 feet to the point of beginning. Being a part of Lot 17, Grand Junction Orchard Mesa Land Company's Orchard

That said owners have caused the said real property to be laid out and surveyed as LINCOLN LANE SUBDIVISION, a subdivision of a part of the County of Mesa;

That said owners do hereby dedicate and set apart all of the streets and roads as shown on the accompanying plat to the use of the public forever and hereby dedicate those portions of said real property which are labeled as utility easements on the accompanying plat as easements for the installation and maintenance of such utilities as telephone and electric lines, poles and cables; storm and sanitary sewer mains; water mains; gas pipe lines; and those portions of said real property which are labeled as irrigation easements on the accompanying plat as easements for the installation and maintenance of irrigation ditches, flumes and conduits;

That all expenses for installation of utilities or ditches referred to above, for grading or landscaping, and for street graveling or improvements shall be financed by the seller or purchaser--- not the County of Mesa.
