
BROZINA SUBDIVISION



DEDICATION

KNOW ALL MEN BY THESE I THE NTS:

That the undersigned Louis J. Brozina and Nadja L. Brozina are the owners of that real property situated in the County of Mesa, State of Colorado and being a part of the NW 1/4 NW 1/4 Section 17, T. 1S, R. 1W. of the Ute Meridian as shown on the accompanying plat, said real property being more particularly described as follows:

Commencing at the Section NW 1/4 NW 1/4 of said Section 17: Thence N 00° 45' 00" W along the East line NW 1/4 NW 1/4 of said Section 17 a distance 3 440.00 feet to a point on the Northerly Right-of-Way of Alcove Drive and the TRUE POINT OF BEGINNING; Thence S 89° 44' 00" W along said Northerly hight-of-Way of Alcove Drive, a distance of 330.00 feet; Thence N 00° 45' 00" W 235.00 feet; Thence N 89° 44' 00" E 330.00 feet to a point on the East line NW 1/4 NW 1/4 of said Section 17; Thence S 00° 45' 00" E along said East line NW 1/4 NW 1/4 of Section 17, a distance of 235.00 feet to the TRUE POINT OF BEGINNING, containing 1.780 acres.

That said owners have caused the said real property to be laid out and surveyed as Brozina Subdivision, a subdivision of a part of Mesa County, Colorado.

That said owners do hereby dedicate and set apart all of the streets and roads as shown on the accompanying plat to the use of the public forever, and hereby dedicate to the Public Utilities those portions of said real property which are labeled as utility easements on the accompanying plat as perpetual easements for the installation and maintenance of utilities, irrigation and drainage facilities, including but not limited to electric lines, gas lines, telephone lines; together with the right of trim interfering trees and brush; with perpetual right of ingress and egress for installation and maintenance of such lines. Such easements and rights shall be utilized in a reasonable and prudent manner.
