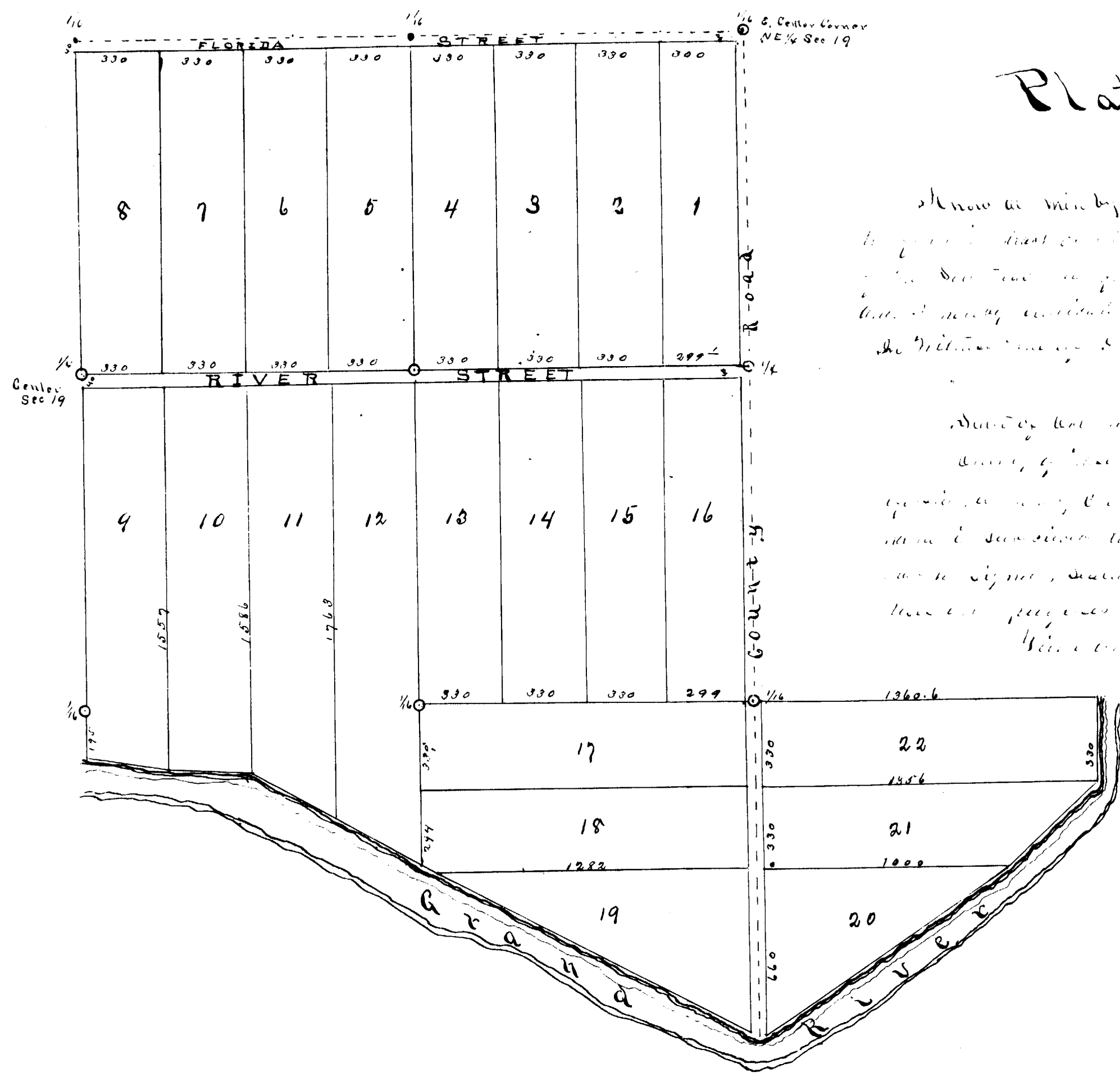


Plat of the Bevier Sub-division

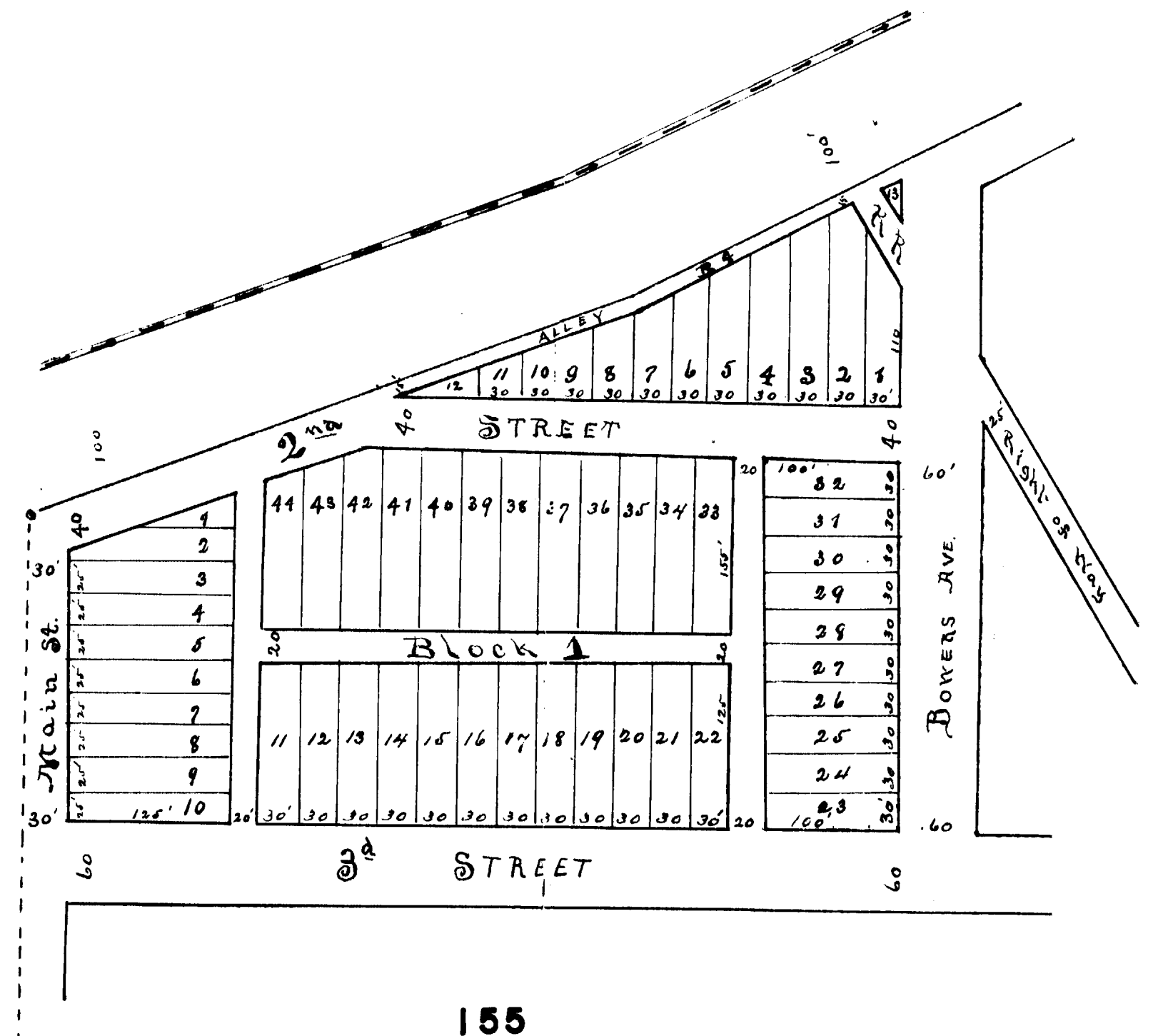
