Beginning at a point which bears East 130.0 feet from the Southwest Corner of Section 2, Township 1 South, Range 1 West of the Ute Meridian, thence North 30 0 feet, thence along the arc of a 25 ft radius curse to the left 39.27 feet, the chord of which bears N45°00'E 35.35 feet, thence along the arc of a 135.0 ft radius curve to the right 83 49 feet, the chord of which bears N17°43'E 82 16 feet, thence North 85 0 feet, thence N 66°07'E 177 17 feet, thence East 140 0 feet, thence N 67°30'E 1000 feet, thence N 87°00'E 3000 feet, thence S 77°51'E 101.49 feet, thence N 76°00'E 175.2 feet, thence South 365 0 feet, thence West 1,013 2 feet to the point of beginning
