KNOW ALL MEN BY THESE PRESENTS

That the undersigned, Leon B Sutherland, Donna L. Sutherland, Harry L Foster and Sara M. Foster are the owners of that real property situated in the County of Mesa, State of Colorado, and lying in the Northeast Quarter of Section 22, Township II South, Range 101 West of the Sixth Principal Meridian, said real property being shown by the accompanying plat thereof, and more particularly described by metes and bounds as follows.

Beginning at a point which is N 89°34' E 7300 feet from the Southwest Corner of NW & NE & Section 22, Township II South, Range IOI West of the 6th P.M., thence N 19°43'E 740' feet, thence N 56°55'E 1360 feet; thence NO8°20' E 65.0 feet to the centerline of an irrigation ditch; thence along the centerline of said ditch N 50°23'E 75.54 feet; thence N 01°31'W 145 13 feet, thence N 34°53'E 99.18 feet; thence N 74°31'E 133.25 feet, thence \$47°00'E 152.43 feet; thence \$24°28'E 288.61 feet; thence \$04°59'W 92.13 feet, thence S 17° 49' W 58.27' feet; thence leaving the centerline of said ditch S 89°34' W 593.0 feet to the point of beginning.

That the said owners have caused the said real property to be laid out and surveyed as Tamarack Subdivision, a subdivision of a part of the County of Mesa;

That said owners do hereby dedicate and set apart all of the streets and roads as shown on the accompanying plat to the use of the public forever and hereby dedicate those portions of said real property which are labeled as utility easements on the accompanying plat as easements for the installation and maintenance of such utilities as telephone and electric lines, poles and cables, storm and sanitary sewer mains, water mains, gas pipe lines, and those portions of said real property which are labeled as irrigation easements on the accompanying plat as easements for the installation and maintenance of irrigation ditches, flumes and conduits,

That all expenses for installation of utilities or ditches referred to above, for grading or landscaping, and for street graveling or improvements shall be financed by the seller or purchaser--- not the County of Mesa
