
CHURCH SUBDIVISION

KNOW ALL MEN BY THESE PRESENTS:

Christian Church (Church of Christ) are the owners of that real property situated in the County of Mesa, State of Colorado, described as follows and shown on the accompanying plat thereof:

Beginning at the SE Corner of Lot 10, Orchard Subdivision, from whence the E 1/4 corner of Sec 30, T IS., R.I.E. of the Ute Meridian bears S 44° 43′ E 934.1′; thence N89° 56′ W 340.0'; thence NOO $^{\circ}$ 06'W 1350'; thence N89 $^{\circ}$ 56'W 226.7'; thence IO4.7' along a curve whose Radius = 50' and whose Central Angle = 120 $^{\circ}$, thence N 89 $^{\circ}$ 56'W 9.7'; thence N 00 $^{\circ}$ 06'W.50' thence S 89 $^{\circ}$ 56'E 9.7'; thence IO4.7 along a curve with R. = 50' & Δ = 120 $^{\circ}$; thence S 89 $^{\circ}$ 56'E 226.7'; thence N.00 $^{\circ}$ 06'W.135'; thence \$89°56'E 340', thence \$00°06'E 320' to the place of beginning.


The tract as described above contains 2.93 acres, more or less, and lies in the NE4 of Sec. 30, T.IS., R IE. of the Ute Meridian, in Mesa County, Colorado, That the said owners have caused the said real property to be laid out and surveyed as CHURCH SUBDIVISION, a subdivision of a part of the County of Mesa; That said owners do hereby dedicate and set apart all of the streets and roads as shown on the accompanying plat to the use of the public forever, and hereby dedicate those portions of said real property which are labeled as utility easements on the accompanying plat as easements for the installation and maintenance of such utilities as telephone and electric lines, poles and cables; storm and sanitary sewer mains; gas pipe lines; and those partions of said real property which are labeled as irrigation easements on the accompanying plat as easements for the installation and maintenance of irrigation ditches, flumes, and conduits; That all expenses for installation of utilities or ditches referred to above, for grading or landscaping, and for street graveling or improvements shall be financed by the seller or purchaser --- not the County of Mesa.
