That the undersigned, John B. and Sybil P Curtis, are the owners of that real property situated in the County of Mesa, State of Colorado, being the E 1/2 of the South 8 acres of the SW 1/4 SE 1/4 SW 1/4 and the South 8 acres of SE1/4 SE1/4 SWI/4 in Section 16, T.IS., RIE., of the Ute P.M., said plat being more specifically described as follows:

Beginning at the Southeast Corner of the Southwest Quarter of Section 16, TIS, RIE, Ute P.M., and considering the Southerly line of the Southwest Quarter of said Section 16 to bear East with all other bearings contained herein relative thereto: thence West 990 22 feet, thence NOO° 07' 15" E 527.88 feet; thence East 990 35 feet; thence SOO°O8'OO"W 527 88 feet to the point of beginning.


