


PLAT OF THE CEDAR MESA ORCHARDS


THE S.W. 1/4 of Sec. 28, T. 9S. R. 95 W. OF THE 6th P.M.

Know all men by these presents:— That I, Anna Clover, being the owner of the S.W. 1/4 of Section 28, Township 9 South, Range 95 West of the 6th P.M., except the South 1/2 of the S.W. 1/4 of the S.W. 1/4 of Sec. 28, of said Township and Range; and I, May A. Sapp, being the owner of the S.W. 1/4 of the S.W. 1/4 of the S.W. 1/4 of said Sec., township, and range, have laid out and platted, as shown on the accompanying map, all of the S.W. 1/4 of Sec. 28, Township 9 South, Range 95 West, of the 6th P.M. to be known under the name of The Cedar Mesa Orchards, and by these presents do grant and dedicate to the County of Mesa, State of Colorado, and the public, the use of roads, described as follows: A strip 15 feet wide and 660 feet long on the East line of the S.W. 1/4 of the S.W. 1/4 of Section 28, Township 9 S. R. 95 W., and a strip 20 feet wide and 1308.9 feet long, on the south line of the S.W. 1/4 of the S.W. 1/4 of Sec. 28, of said Township and Range. All other roads shown on this map are reserved. 


