
## SCHLEISMAN SUBDIVISION

## DEDICATION

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, PAUL P SCHLEISMAN and VERLEEN V. SCHLEISMAN buyers of that property situated in the SE 1/4 SE 1/4 Sec. 10, T.1S., R.1E., Ute Meridian, said tract being more particularly described as follows:

Beginning at a point 261.33 feet West and 167 feet North of the Southeast Section Corner of Section 10, T.IS., R.IE., Ute Meridian; Thence North 0°29'East 333 feet; Thence East 258.5 feet; Thence South 333 feet; Thence West 261.33 feet more or less to point of beginning.

That said buyers have caused the said real property to be laid out and surveyed as SCHLEISMAN SUBDIVISION, a subdivision of a part of the County of Mesa;

That said buyers do hereby dedicate and set apart all of the streets and roads as shown on the accompanying plat to the use of the public forever and hereby dedicate those portions of said real property which are labeled as Utility Easements on the accompanying plat as easements for the installation and maintenance of such utilities as telephone and electric lines, poles and cables; storm and sanitary sewer mains; water mains; gas pipe lines; and those portions of said real property which are labeled as irrigation easements on the accompanying plat as easements for the installation and maintenance of irrigation ditches, flumes and conduits;

That all expenses for installation of utilities or ditches referred to above, for grading or landscaping, and for street gravelling or improvements shall be financed by the seller or purchaser ---- not the County of Mesa.
