STATEMENT OF OWNERSHIP AND DEDICATION

\* All Public Pedestrian Easements are dedicated to the City of Grand Junction as perpetual easements for ingress and egress access use by the public forever for constructing, installing, maintaining and repairing a trall for purposes of walking, running, wheelchairs (motorized and nonmotorized), bicycling and other nonmotoized forms of transportation for commuting and recreational purposes with or without pets accompanying them.

\* All Irrigation easements to be granted to the Countrypiace Estates Homeowners' Association for the benefit of the owners of the lots and tracts hereby platted as undivided interests (not partitionable), as perpetual easements for the installation, operation, maintenance and repair of irrigation systems to supply and drain

\* All drainage easements to be granted to the Countryplace Estates Homeowners' Association for the benefit of the owners of the lots and tracts hereby platted as undivided interests (not partitionable), as perpetual easements for the installation, operation, maintenance and repair of systems for the conveyance of stormwater which originates on the property platted.

\* Tracts A-E to be granted by separate instrument to the Countryplace Estates Homeowners' Association as common open space, subject to terms and conditions set forth in said grant.


