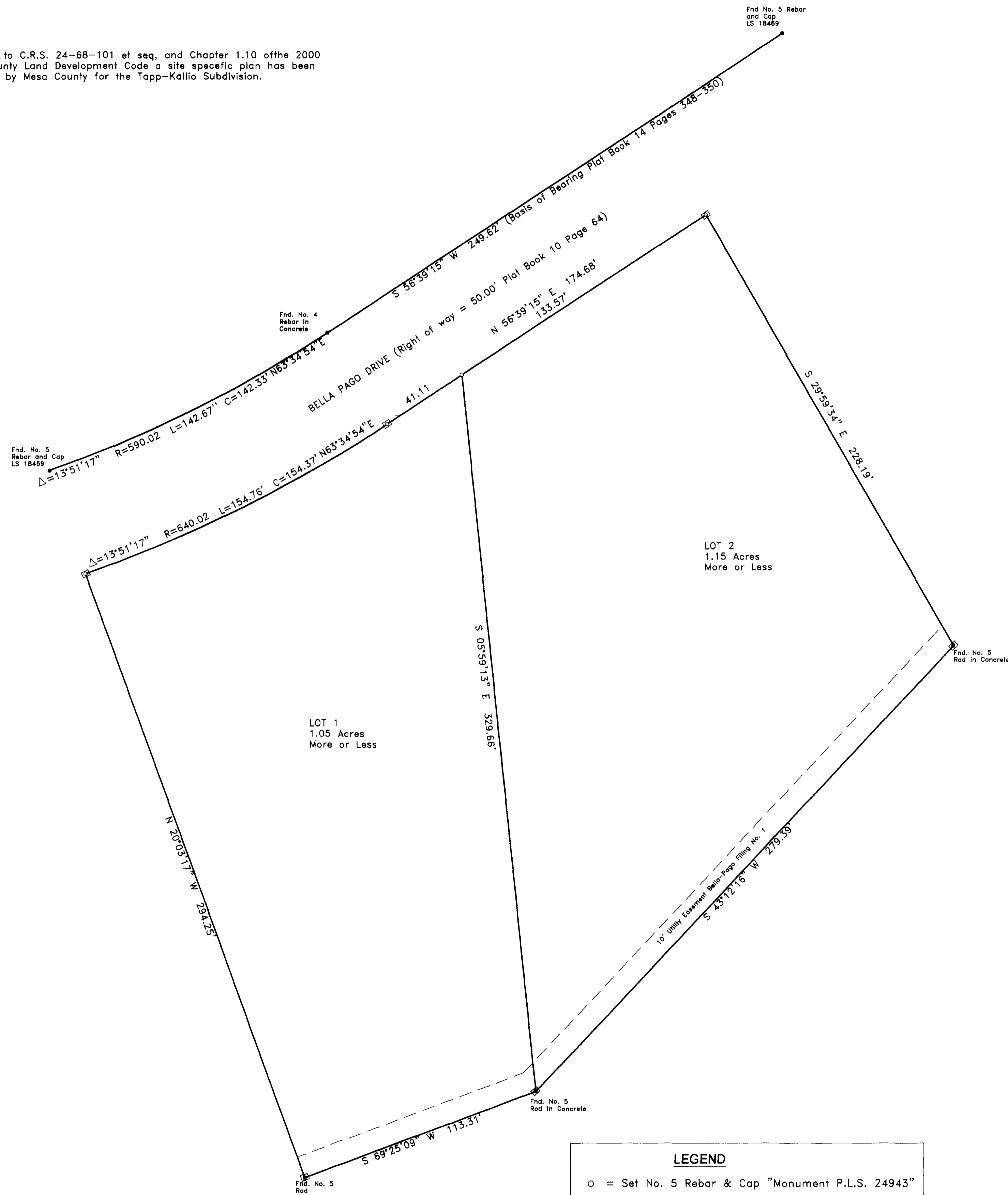


TAPP-KALLIO SUBDIVISION

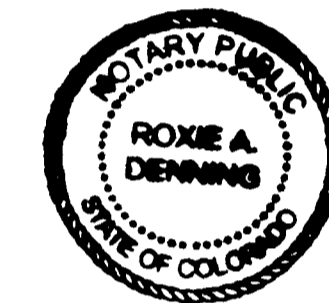

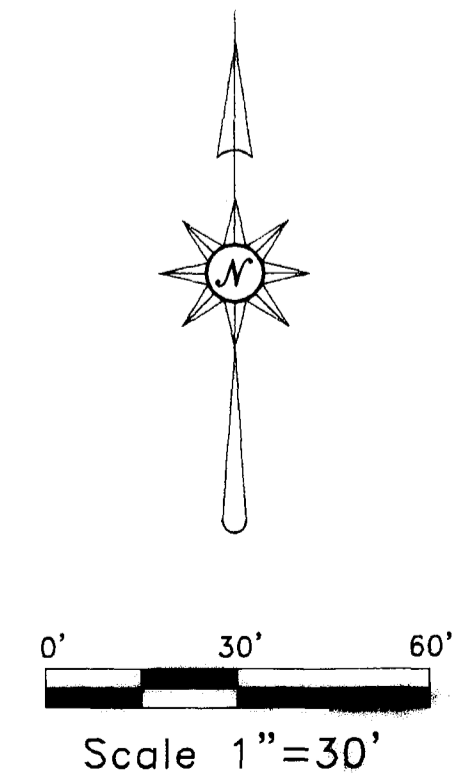

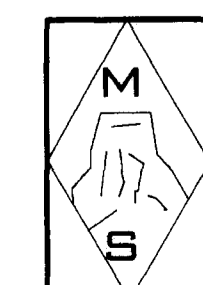
Restrictions appurtenant to the respective lots shown on this plat are designated on the associated Site Plan recorded in the office of the Mesa County Clerk and Recorder.
