

Dear Mrs. Jouflas:

As a condition attached to the granting of the liquor license for Aurelios, two things were to be done to improve access:

- 1. The north alley right-of-way was to be increased to 22 feet (an additional 7 feet of right-of-way).
- The curb cut on Glenwood was to be widened to reflect this increased alley width.

There was no definite requirement as to whether the seven feet (7) would be to the west or to the east or part from each, although it was assumed it would be from the undeveloped land to the west. When the south section of alley was vacated, you gained 15 feet of North Avenue frontage for your development and we feel that the deed for the extra width of the north section is overdue. The plan presented and made part of the final permission also included some landscaping at the front of the parking lot.

Since the conditional use included the above action, the liquor license is in jeopardy until the alley is widened and landscaping provided. Please let us know when this will be accomplished.
