

Attached is a petition for road vacation along Elm Ave. East of 12th Street in the City of Grand Junction.

The petitioner requests that 10 feet of dedicated R.O.W. along Elm Ave. be vacated. This R.O.W. was granted to the City of Grand Junction in 1949 by Quit Claim Deed.

Note that the City is presently operating on an existing 10' roadway easement across lots east of the requested vacation. This easement was granted in 1951.

The petitioner has met with the City Engineering Department prior to this submittal. The Engineering Department is not aware of any plans to change Elm Ave. The Engineering Department stated that it would have no problems vacating the requested R.O.W. as long as an easement would be granted to the City.

The petitioner will provide a roadway easement for the requested R.O.W. vacation once the request has received approval by the City Council.
