
It will be imperative to tether the goat no closer than 100 feet from the nearest residential structure, unless written permission is granted. (See Section 5-10-3 B.1)

Dear Ms. Garoutte:

In response to your questions of the last few days, allow me to go through what is required in order to keep a goat within the City limits. One of the first steps to take is to schedule an appointment with one of the Planners for a pre-application conference for a Conditional Use to keep a goat. The time line for submittals is as follows:

1. The submittal deadline is the first working day of the month.

 The Planning Commission normally meets on the first Tuesday of the following month. If the Conditional Use is approved by the Planning Commission and no appeals to City Council, that is the end of hearings.
 If the Planning Commission denies the submittal, you have

the opportunity to appeal it to the City Council. 4. The City Council normally meets on the first and third Wednesdays of the month.

The fee for a Conditional Use Permit is 420.00. There is a provision in the Grand Junction Zoning & Development Code so that you may request a waiver of fees from the City Council. The request shall be submitted to the Planning Department and heard by Council at a regularly scheduled public hearing. Enclosed is Section 2-2-2.G.16. which refers to the fee waiver procedure.

Normally, the applicant goes through the pre-application process, submits the application and pays the fee. The check is then held until the City Council makes a decision regarding the waiver of fees. Meanwhile, the proposal has been heard by the Planning Commission, thus saving time.

During our phone conversations, you had mentioned that the animal regulations referred to a 30 day period to relocate animals. The 30 day period refers specifically to the revocation of permission to fence an animal 20 feet from a principal residential structure on an adjoining property. In the case of a complaint such as the one this Department received about your goat, the 30 days does not apply. The amount of time allocated for the relocation of the

animal(s) is at the discretion of the zoning enforcement officer. Section 5-10-3.B.2. states:

> ... No person shall keep, house or shelter one or more pigs, goats, burros or mules unless such person has obtained a conditional use permit in accordannce with the provisions of Section 4-6 and 4-8 of this Code.

Dear Ms. Garoutte:

You will recall that you and I talked about what is required for keeping of a goat within the City limits.

I believe we agreed that there were two steps that you needed to consider:

- a. Approval from the Planning Commission (technically this means obtaining a conditional use permit);
- b. Whether or not you have to pay the \$420 fee.

As I recall, you indicated that you would be unable to make a request to the City Council for any fee waiver until August. I told you that I had no objection to your making the request to the City Council for the waiver of the fee first. That made sense to me since if Council denied your request (if you were required to pay the \$420) there would be no purpose for your going to the Planning Commission, since keeping of the goat was not worth that much. If Council approves the fee waiver then it made sense for you to apply to the Planning Commission for the conditional use permit.

We discussed that this process was a little unusual and that normally the applicant for a permit must pay the fee up front before going to the Planning Commission. I suggested that I would recommend "bending the rules" since the issue is the keeping of one goat and not a major development.

In Linda Weitzel's letter of May 31 she describes the technical submittal requirements. Before you leave town, please call Planning to make certain that you don't miss the deadline. By copy of this letter I am asking Linda Weitzel to coordinate the deadline dates to get you in front of the City Council and the Planning Commission. Kathy Garoutte June 6, 1990 Page 2

When we ended our conversation, we agreed that you would submit your request in writing. As Ms. Weitzel indicated, to be safe, you should call the Planning department, meet with a planner to get direction on <u>what</u> to submit.

I appreciate the opportunity to talk with you and want to remind you that if you have any questions or concerns after reading this letter or after you contact the Planning department, please feel free to call me directly.

This Conditional Use Permit was denied by the Planning Commission and appealed by the petitioner. The Planning Commission felt that the area was residential and not agricultural. The petitioner feels that the goat can be kept as a pet and would not have an adverse impact on the neighborhood. This department received two letters of opposition and during the Planning Commission Hearing, one adjacent landowner spoke about his concerns regarding the goat. The majority of adjacent landowners signed a petition (see attached) in favor of keeping the goat.

STATUS & RECOMMENDATIONS:

Planning staff feels that the petitioner has answered all concerns about keeping the goat. Although she has not received written permission to keep the goat less than 100 feet from all the adjacent land owners, she does have the majority of signatures and at this time she is negotiating with the remaining two owners.

Planning Commission Action

Planning Commission denied the request by a vote of 4-3.

Mrs. Garoutte was contacted on May 24, 1990 by Code Enforcement Officer Blaine Powell about a complaint that she was keeping a goat. According to the Grand Junction Zoning & Development Code, a Conditional Use Permit is required in order to keep a goat. No Conditional Use Permit had been applied for.

The Garoutte's did find another home for the goat, however, they would like to be able to have one at a later date. Mrs. Garoutte had contacted Paul Nelson and Dan Wilson about this. Dan suggested that she apply for a fee waiver (\$420.00) for the Conditional Use Permit because Mrs. Garoutte had indicated that it would be a financial hardship to pay the fee.

In order to cooperate with the Garoutte's, Dan suggested that Mrs. Garoutte apply for the fee waiver before submitting the application for Conditional Use. Mrs. Garoutte has been through a pre-application conference for a Conditional Use and should be prepared to submit it pending the decision on her fee waiver request.

MEMORANDUM

TO: CITY COUNCIL FROM: LINDA WEITZEL AAA DATE: SEPTEMBER 18, 1990 RE: #40-90 CONDITIONAL USE TO KEEP A GOAT

As requested from the Monday night workshop, the following are some suggestions for conditions to keep a goat at 318 27 3/8 Road:

1. Manure shall disposed of properly so that it does not create an odor problem.

2. The goat shall remain tethered at all times. The location shall be changed often enough so that it does not create a manure problem. It is understood that she may be walked on a leash.

3. The goat shall be tethered no closer than 20 feet to an adjacent structure with written permission from the occupant or property owner. She shall be tethered no closer than 100 feet to an adjacent structure when no permission for a lesser distance has been obtained.

4. If the goat is to be bred, the kids (offspring) shall be kept no longer than 4 months. The milk and milk products shall be used solely by the Garoutte family.

5. Responsible ownership/veterinarian care is expected. Any required vaccinations, etc. will be provided.

6. It is understood that the Conditional Use permit can be revoked if valid complaints are received and the a solution cannot be found that is reasonable to all the parties concerned.

ACTION REQUESTED:

Council consideration of a request for a variance fee waiver or reduction.

EXECUTIVE SUMMARY:

Kathy Garoutte is requesting a fee waiver or fee reduction for a variance request to the Board of Appeals to allow her goat to be kept closer than the required minimum distance of 100 feet from a principal residential structure on an adjoining property.

FISCAL IMPACT:

The fee for a variance request is \$115.00 to cover staff review time, legal notices and notification of property owners within 200 feet.

* BACKGROUND/ISSUES/OPTIONS:

Section 2-2-2.G.16 of the Zoning and Development Code allows the City Council to "waive fees required in cases of exceptional hardship or other good cause as may be demonstrated by the applicant". Council did grant the applicant a fee reduction for the original Conditional Use Permit for the goat, from \$420.00 to \$25.00.

RECOMMENDATION:

The applicant has not demonstrated exceptional hardship or other good cause as required by the Code. Staff recommends denial of the request to waive the fee.

City permit cost almost gets her goat

Kathy Garoutte thought it seemed like a baaaad idea to spend \$420 for a permit to keep a \$15 goat. Surely, the city of Grand Junction had to be kidding. They wouldn't ram that down her throat.

She was right. The City Council agreed to waive the \$420 conditional-use permit fee for the goat and decided \$25 would be reasonable.

Garoutte only wanted a little goat to act as a weedeater, she said, so she spent \$15 for a Nubian goat named Nanny.

Nanny had lived with the Garouttes at 318 Road 27 3/8 for about a week when there was a knock at the door and a city official said Nanny had to butt out — no goats allowed.

Garoutte got rid of her goat — which went on to take second place at the Mesa County Fair as Emma, her new name.

Garoutte said she was amazed and delighted with the council's decision and will start filling out reams of paperwork to get her goat again.
