ACTION REQUESTED: Adopting by resolution the 1996 amended Municipal Annexation Plan.

LOCATION: The Municipal Annexation Plan boundary goes from 19 Road to 33 1/2 Road and from A Road to I Road.

APPLICANT: City of Grand Junction

EXECUTIVE SUMMARY: CRS 31-12-101, et seq. requires yearly review and updating, if necessary, to the Municipal Annexation Plan. This plan describes the area within which possible annexation may occur, existing and proposed infrastructure, City services, and proposed land uses. The 1996 Municipal Annexation plan incorporates minor changes to the descriptions of City facilities and services and adds additional information that helps clarify municipal services that can be expected for newly annexed areas. Upon adoption, this plan will be forwarded to the County Commissioners as required by State Statutes.

STAFF ANALYSIS: Colorado State Statutes require each municipality to adopt a Municipal Annexation Plan and forward this plan to the County Commissioners. This plan must be reviewed and amended, if necessary, every year. State Statutes do not require formal Council action for the yearly updates to the plan. However, historically Council has adopted the yearly updated plan by resolution.

Changes to the G.J. Municipal Annexation Plan as amended for 1996 include:

- 1) information on wastewater and solid waste services including a map showing the special sanitation district boundaries;
- 2) updating police services;
- 3) information on roads, bridges and other transportation issues, including a map of the proposed Grand Junction Street Classification;
- 4) updating City parks information and future needs;
- 5) providing a map which shows the 3 mile annexation limit and its'

relationship with the Municipal Annexation Plan boundary and the current City limits;

- 6) updating the Land Use section with updates of the past year's long range planning efforts by the City; and
- 7) updating the municipal annexation map to better reflect existing conditions.
 - A new land use category was created called "Low Density Residential/Agricultural" which better identifies those areas that are large lot residential development and/or agricultural uses. The areas specifically identified are the Appleton area north of I-70 and on Orchard Mesa mainly between 30 Road and 33 Road. In previous years, we have identified those areas as Parks/Open Space/Agricultural. This new land use category reflects the recommended land uses for the Orchard Mesa area as adopted in the 1995 Orchard Mesa Neighborhood Plan. The majority of the area is outside of the 201 Sewer Service boundary.
 - b) updating the City limits with the annexations that have occurred during the past year.

STAFF RECOMMENDATION: Staff recommends adoption of the 1996 Municipal Annexation Plan and requests that Council consider the resolution on the regular City Council agenda for Wednesday, March 20, 1996.
