CONSTRUCTION NOTES:

- 1a INSTALL 6" C900, CLASS 150 PVC PIPE W/TRACER WIRE. MINIMUM SLOPE +0.4%, MINIMUM 48" COVER.
- 1b CONTRACTOR SHALL VERIFY DEPTH OF EXISTING FORCEMAIN PRIOR TO PLACEMENT OF NEW FORCEMAIN. DEPTH OF EXISTING FORCEMAIN IS APPROX. 7'.
- 1c CLEANOUT PER DETAIL SHEET NO. 2
- 2a ASPHALT PATCH - 6" AGGREGATE BASE COURSE, 3" HOT BITUMINOUS PAVEMENT.
- 2b ASPHALT CUT & PATCH - CUT ASPHALT TO A STRAIGHT LINE ONE FOOT FROM THE TOP OF TRENCH. CUT ASPHALT PERPENDICULAR TO THE EXISTING EDGE. THE MINIMUM WIDTH OF PATCH OR OF EXISTING ASPHALT TO REMAIN BETWEEN THE EDGE AND THE PATCH SHALL BE 4 FEET.
- 2c SHOULDER REPAIR - 6" AGGREGATE BASE COURSE. MAXIMUM PAY WIDTH - 6'. THE SHOULDER AREA OUTSIDE THE PAY WIDTH SHALL BE PROTECTED FROM CONTAMINATION OR RESTORED BY THE CONTRACTOR. IF EXISTING GRAVEL IS NOT ALL AGGREGATE BASE COURSE CONSULT WITH PROPERTY OWNER AND MATCH EXISTING MATERIAL OR INSTALL A.B.C. AS THEY DESIRE.
- 3a REMOVE & REPLACE BARRICADE AS NEEDED.
- 4a TIE INTO EXISTING LIFT STATION, COORDINATE WITH LARRY BROWN AT THE PERSIGO WASTEWATER TREATMENT PLANT 244-1590.

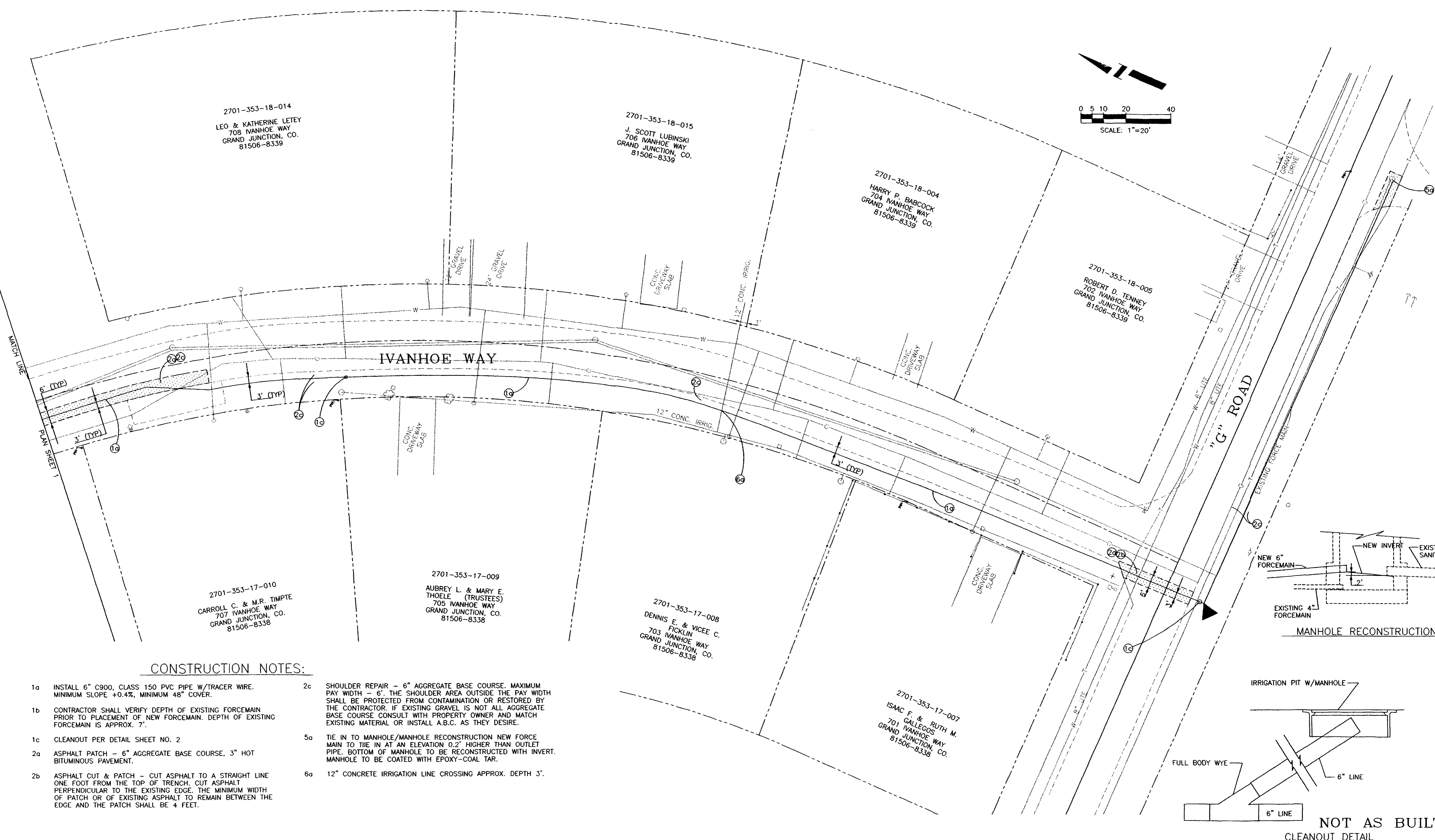

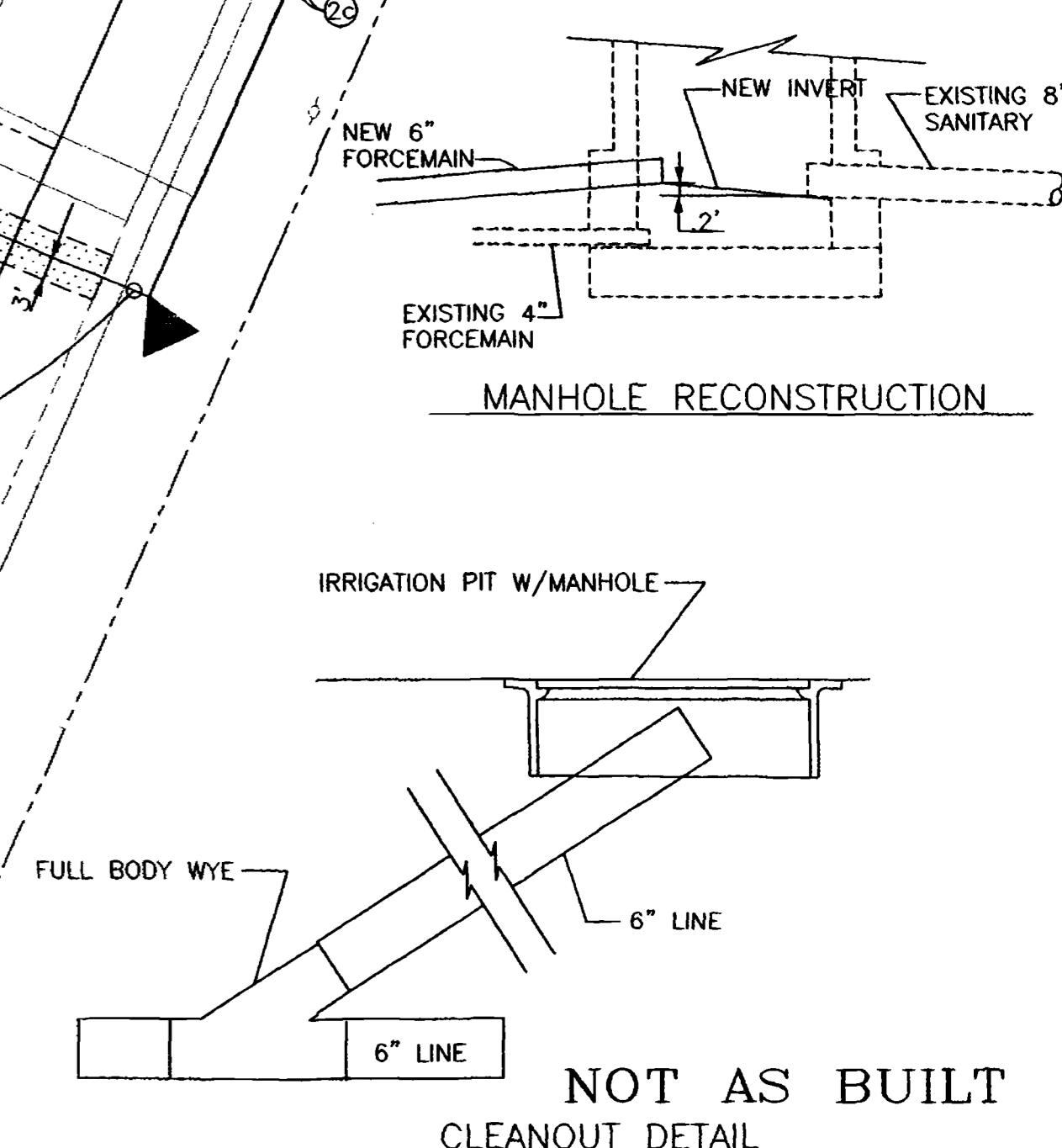

CONSTRUCTION NOTES:

- 1a INSTALL 6" C900, CLASS 150 PVC PIPE W/TRACER WIRE. MINIMUM SLOPE +0.4%, MINIMUM 48" COVER.
- 1b CONTRACTOR SHALL VERIFY DEPTH OF EXISTING FORCEMAIN PRIOR TO PLACEMENT OF NEW FORCEMAIN. DEPTH OF EXISTING FORCEMAIN IS APPROX. 7'.
- 1c CLEANOUT PER DETAIL SHEET NO. 2
- 2a ASPHALT PATCH - 6" AGGREGATE BASE COURSE, 3" HOT BITUMINOUS PAVEMENT.
- 2b ASPHALT CUT & PATCH - CUT ASPHALT TO A STRAIGHT LINE ONE FOOT FROM THE TOP OF TRENCH. CUT ASPHALT PERPENDICULAR TO THE EXISTING EDGE. THE MINIMUM WIDTH OF PATCH OR OF EXISTING ASPHALT TO REMAIN BETWEEN THE EDGE AND THE PATCH SHALL BE 4 FEET.
- 2c SHOULDER REPAIR - 6" AGGREGATE BASE COURSE. MAXIMUM PAY WIDTH - 6'. THE SHOULDER AREA OUTSIDE THE PAY WIDTH SHALL BE PROTECTED FROM CONTAMINATION OR RESTORED BY THE CONTRACTOR. IF EXISTING GRAVEL IS NOT ALL AGGREGATE BASE COURSE CONSULT WITH PROPERTY OWNER AND MATCH EXISTING MATERIAL OR INSTALL A.B.C. AS THEY DESIRE.
- 5a TIE IN TO MANHOLE/MANHOLE RECONSTRUCTION NEW FORCE MAIN TO TIE IN AT AN ELEVATION 0.2' HIGHER THAN OUTLET PIPE. BOTTOM OF MANHOLE TO BE RECONSTRUCTED WITH INVERT. MANHOLE TO BE COATED WITH EPOXY-COAL TAR.
- 6a 12" CONCRETE IRRIGATION LINE CROSSING APPROX. DEPTH 3'.
