ZONING THE DIAMOND RIDGE ANNEXATION LOCATED AT 2520 F-1/2 Road

Recitals.

The Diamond Ridge subdivision located at 2520 F-1/2 Road is in the process of being annexed to the City of Grand Junction. A rezone from the Mesa County zoning of Agriculture Forestry Transition (AFT) to a City Planned Residential 4.2 units per acre (PR-4.2) zoning is proposed. The City Council finds that the request meets the goals and policies and future land use set forth by the *Growth Plan* (4-7.9 units per acre). City Council also finds that the requirements for a rezone and Zone of Annexation as set forth in Sections 4-4-4 and Section 4-11 of the Zoning and Development Code have been satisfied.

The Grand Junction Planning Commission, at its February 16, 1999 hearing, recommended approval of the rezone request from AFT to PR-4.2.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION THAT THE PARCEL DESCRIBED BELOW IS HEREBY ZONED PLANNED RESIDENTIAL 4.2 UNITS PER ACRE (PR-4.2):
