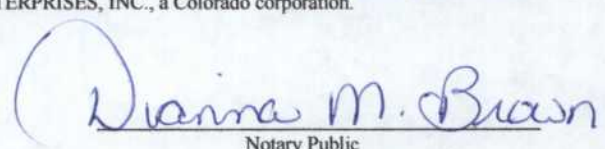

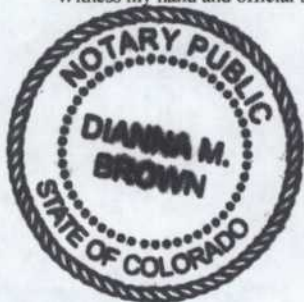

QUITCLAIM DEED

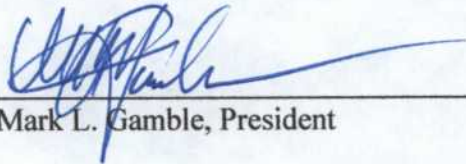

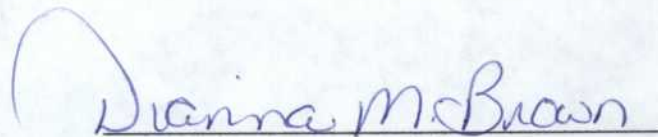
